**13. REMINDER: Sign up CHIE, the Hampshire & IoW Shared Care Record**

For access to the Hampshire Patient Shared Care Records (known as CHIE), please make sure you have signed up. Open to both employed pharmacists and locums. Please note CHIE needs to be accessed every 15 days otherwise the account is locked.
