# Annual flu letter published for 2020/2021

The Department of Health and Social Care, Public Health England and NHS England and NHS Improvement have jointly published a **letter** to provide further information on the national flu immunisation programme for 2020–21. The letter notes that this coming winter we may be faced with co-circulation of COVID-19 and flu.

There will undoubtedly be some changes to the way in which the NHS flu vaccination service is delivered this year in response to the COVID-19 pandemic and new social distancing requirements. As usual, PSNC will be negotiating those details with NHSE&I as soon as they are in a position to do so.

In preparation for the 2020/21 season, at its meeting next week PSNC will be considering how the flu vaccination service might work differently in community pharmacies this year.

## **COVID-19 support: Wellbeing during challenging times**

Pharmacists and their teams have been spending all of their time through this pandemic serving their patients and their communities. PSNC's COVID-19 hub has an **FAQs page** with a large number of answers to queries posed by pharmacy contractors, their teams and LPCs; these are being updated on an almost daily basis. Recent additions include:

#### Q. Are pharmacy staff eligible for testing, and if so, how is this accessed?

Yes, frontline workers, including community pharmacy staff in England, can access free testing for COVID-19, via the Department of Health and Social Care's (DHSC) national testing service. Testing will allow those currently unable to return to work because they or a member of their family or household have symptoms of coronavirus to know whether they do have the virus.

A new portal for booking COVID-19 tests for key workers, including community pharmacy team members, is now available for use by team members and employers: **Essential workers: apply for a coronavirus test (GOV.UK)** 

# Q. Has the possibility of introducing a pharmacy COVID-19 immunisation programme been broached yet in talks with DHSC?

A vaccine for the COVID-19 coronavirus has yet to be determined. Once such a vaccine exists and is available in sufficient quantities, there may be an opportunity for community pharmacies to be one of the vaccine providers.
