## **CHAMPIX PGD**

Smokefree Hampshire has launched the new **Champix (Varenicline) PGD** across Hampshire. We are currently working with <u>23</u> pharmacies who are providing the service.

This new service is open to all pharmacies interested in offering Varenicline to their customers and is separate to the current SLA. The aim of the PGD is to increase accessibility for people who want to use Varenicline to stop smoking.
