## 1. ACTION: Data Security & Protection Toolkit

## 2. INFORMATION: Pharmacy First Clinical Pathway Caps

## 3. INFORMATION: Pharmacy First Clinical Pathway Monthly Payment Eligibility

From June, pharmacies must also be registered and be able to deliver the Hypertension Case Finding Service and the Pharmacy Contraception Service (PCS) to be eligible for the fixed monthly payment for achieving the minimum number of clinical pathways. <u>https://cpsc.org.uk/news/latest-cpsc-news/pharmacy-first-service-bundling-requirements</u>
