## Re: Dementia Friendly Pharmacies Framework

NHS England - South (Wessex) Pharmacy Local Professional Network has been developing a Dementia Friendly Pharmacy Framework, with the aim of having 400 Dementia Friendly Pharmacies across Wessex by 31<sup>st</sup> March 2018.

Following the submission deadline of 31<sup>st</sup> March 2018, NHS England will complete random validation visits to pharmacies that have submitted a declaration on PharmOutcomes.
