This daily update contains important information for community pharmacy teams about the ongoing response to the COVID-19 pandemic.

## **In today's update: DHSC plans for end of Brexit transition; Pharmacy Representation Review next steps webinar; RPS inclusion and diversity group.**

### **Brexit: DHSC plans for end of Transition Period**

The Department of Health and Social Care (DHSC) has clarified its plans for the continuity of supply of medicines and medical goods after the end of the Brexit Transition Period.

In a letter to suppliers of medicines and medicinal products, DHSC's Chief Commercial Officer Steve Oldfield set out the Government's preparations alongside its expectations of the industry in the run up to 31st December 2020. This includes requests to aim to hold six weeks' worth of stock in the UK and to urgently review their own contingency plans for the possibility of a worst-case scenario.

In preparation for leaving the EU (prior to the start of the Transition Period), DHSC developed a multi-layered approach for protecting the supply of medicines and medical goods. These measures have been revisited for the end of the Transition Period, and adapted where necessary.

### **Q. I am struggling to obtain generic medicines at a reasonable price, will I be adequately reimbursed?**

PSNC is keeping a close eye on the generic medicines affected by recent price hikes and is in discussions with DHSC on protection for pharmacies against sudden price rises. Where purchase prices are reported to be above the listed Drug Tariff prices, PSNC continues to make applications to DHSC for price concessions in the usual way. PSNC relies on contractor reports to make its application and we urge contractors to get in touch with us to report any supply issues by using the [online reporting form](#) to give us an accurate picture of developing issues.
