APPG launches inquiry into the impact of COVID-19 on pharmacy

The All-Party Pharmacy Group (APPG) has launched a rapid inquiry to examine the impact of COVID-19 on pharmacy. Looking at a range of financial and operational pressures on the sector, the inquiry aims to establish a set of recommendations to put to the Government, outlining the additional support the sector requires.

To help inform this work, a survey of pharmacy staff has been published which contractors and pharmacy teams are encouraged to complete. The survey closes on Monday 30th November 2020, but should only take between 5-10 minutes to complete.

PQS Part 2 Evidence Checklist & PharmOutcomes Framework

Contractors should collect evidence to assure themselves that they meet all the requirements for each criteria within a PQS Part 2 domain, as well as for validation checks. PharmOutcomes PQS framework

As contractors and their teams complete each criterion, they can mark this on PharmOutcomes to track their progress with achieving the quality criteria. This can be accessed by logging into [PharmOutcomes](#) and selecting 'Assessments'. The framework is listed as '**Pharmacy Quality Scheme 2020/21 – Part 2**'.
