This daily update contains important information for community pharmacy teams about the ongoing response to the COVID-19 pandemic.

# In today's update: end of Pandemic Delivery Service; free cancer conversations training; Simvador recall; medicine supply updates.

## **Reminder: Pandemic Delivery Service ends today**

Pharmacy contractors are reminded that the <u>Pandemic Delivery Service</u> is commissioned **until today, Thursday 3rd December 2020**; deliveries to shielded patients can continue to be made under the service until the end of today. This follows the end of the national lockdown on 2nd December 2020, with clinically extremely vulnerable patients no longer being advised to shield themselves.

# <u>DHSC guidance on shielding and protecting people who are clinically extremely</u> vulnerable from COVID-19 from 2nd December

Contractors can claim payments for deliveries made under the Advanced service via the **Manage Your Service (MYS) portal**; claims should be submitted by 5th January 2021.

If formal shielding is advised for the clinically extremely vulnerable again, NHS England and NHS Improvement (NHSE&I) may then issue a notice to re-commence the service in certain areas.

#### MHRA medicines recall notice

The Medicines and Healthcare Regulatory Agency (MHRA) has issued a class 3 medicines recall for:

#### Simvador 10mg, 20mg and 40mg tablets (Lupin Healthcare (UK) Limited)

Lupin Healthcare (UK) Limited has informed the MHRA that some batches of Simvador tablets have been packaged with a version of the patient information leaflet (PIL) that does not include the most up to date safety information. There are no concerns with the quality, safety and efficacy of the product, but the affected batches are being recalled due to concerns around the omission of the safety information.
