Sulfadiazine silver (Flamazine[®]) 1% cream Tier 2 – medium impact^{*} Date of issue: 08/05/2024 Link: <u>Medicines Supply Tool</u>

Summary

- Flamazine[®] 1% cream 20g, 50g and 500g packs are out of stock until early August 2024.
- Flamazine[®] 1% cream 250g packs will be out of stock from mid-May 2024 until early August 2024.
- Alternative products for the treatment of burns and wound care remain available and can support increased demand.
- Unlicensed supplies of Flammacerium[®] and Silvadene[®] creams have been sourced, lead times vary.

Actions Required

Clinicians should:

- review if Flamazine[®] cream is the most appropriate treatment and ensure that where available, it is used sparingly and not for longer than clinically necessary; and
- prioritise any remaining supplies for use in patients with burns.

Where there are insufficient supplies of Flamazine® cream, clinicians should:

- consider prescribing an alternative product including Flaminal[®] gels, UrgoTul[®] dressings, Acticoat[®] dressings or Prontosan[®] gels where appropriate, taking into account the ease of use, patient preference and tolerability (see Supporting information); or
- consider prescribing unlicensed Flammacerium[®] or Silvadene[®] cream containing sulfadiazine silver 1%, only where licensed alternatives are not appropriate. Prescribers should work with local pharmacy teams to ensure orders are placed within appropriate time frames as lead times may vary (see Supporting information); and
- if the above options are not considered appropriate, advice should be sought from burns or tissue viability specialists on management options.

Supporting information

Flamazine[®] cream contains silver sulfadiazine, a bacteriostatic and bactericidal agent. It is licensed for the prophylaxis and treatment of infection in burn wounds. It may also be used as an aid to the short-term treatment of infection in leg ulcers and pressure sores, and as an aid to the prophylaxis of infection in skin graft donor sites and extensive abrasions. It is also licensed for the conservative management of finger-tip injuries where pulp, nail loss and/or partial loss of the distal phalanx has occurred. Tubes should be discarded 7 days after opening and the 250g and 500g pots 24 hours after opening. The contents of one container are for the treatment of one person.

Guidance on ordering and prescribing unlicensed imports

- Alliance Pharma (cerium nitrate hexahydrate 22mg/g/sulfadiazine silver (Flammacerium[®]) 10mg/g cream)

Any decision to prescribe an unlicensed medicine must consider the relevant guidance and NHS Trust or local governance procedures. Unlicensed imports do not undergo any central quality assessment or suitability evaluation. Therefore, any import must be locally assessed in line with local unlicensed medicines processes.
