Co-trimoxazole 40mg/200mg/5ml oral suspension sugar free

Tier 2 – medium impact* Date of issue: 05/06/2024 Link: <u>Medicines Supply Tool</u>

Summary

- Co-trimoxazole 40mg/200mg/5ml oral suspension sugar free is out of stock until early September 2024.
- Co-trimoxazole 80mg/400mg/5ml oral suspension remains available and can support increased demand.
- Unlicensed imports of co-trimoxazole 40mg/200mg/5ml oral suspension sugar free can be sourced, lead times vary.

Actions Required

All clinicians/prescribers should:

- consider prescribing co-trimoxazole 80mg/400mg/5ml oral suspension, the excipients differ from those of co-trimoxazole 40mg/200mg/5ml oral suspension, therefore before switching ensure that the patient is not intolerant to any of the excipients, and is counselled on the appropriate dose and volume required (see Supporting information);
- consider prescribing unlicensed products only where licensed alternatives are not appropriate.
 Prescribers should work with local pharmacy teams to ensure orders are placed within appropriate time frames as lead times may vary (see Supporting information); and
- if the above options are not considered appropriate, advice should be sought from specialists on management options.

Supporting information

Clinical Information

Co-trimoxazole **40mg/200mg/5ml** oral suspension sugar free is licensed for use in children aged 12 years and under (infants [>6 weeks to <2 years old] and children [>2 to <12 years old]).

Co-trimoxazole **80mg/400mg/5ml** oral suspension is licensed for use in children aged >12 to <18 years and adults.

Co-trimoxazole 80mg/400mg/5ml oral suspension contains different excipients to co-trimoxazole 40mg/200mg/5ml oral suspension sugar free and may not be as palatable for some children. Patients with rare hereditary problems of fructose intolerance, glucose-galactose malabsorption or sucrose-isomaltase insufficiency should not take this medicine. However, in other patients, it may be considered for off-label use, once it is confirmed that the patient is not intolerant to any of the excipients, and the patient/carer is counselled on the appropriate dose and volume required.

NOTE: 5ml of co-trimoxazole 40mg/200mg suspension = 2.5ml of co-trimoxazole 80mg/400mg suspension.

Guidance on ordering and prescribing unlicensed imports

The following specialist importers have confirmed they can source unlicensed co-trimoxazole 40mg/200mg/5ml oral suspension sugar free (please note there may be other companies that can also source supplies):

Any decision to prescribe an unlicensed medicine must consider the relevant guidance and NHS Trust or local governance procedures. Unlicensed imports do not undergo any central quality assessment or suitability evaluation. Therefore, any import must be locally assessed in line with local unlicensed medicines processes.

When prescribing a product that is not licensed in the UK due to a supply issue with the licensed alternative prescribers must indicate on the FP10 prescription that an unlicensed product is required. This can be done in one of the following two ways:

- Electronic prescriptions if the required unlicensed product is shown on electronic prescribing systems, GPs should select:
 - o co-trimoxazole 40mg/200mg/5ml oral suspension sugar free (imported)
- Paper prescriptions where the unlicensed product is not shown on electronic prescribing systems, GPs should use a paper prescription and annotate with the following wording: "**special order**".
